

# United Kingdom

## Human Capital Index 2020

This brief provides an update to the Human Capital Index (HCI). First launched in 2018, the HCI measures the amount of human capital that a child born today can expect to attain by age 18. It conveys the productivity of the next generation of workers compared to a benchmark of complete education and full health. Worldwide a child born in 2020 can expect, on average, to be 56 percent as productive as she could be when she grows up. All data represent the status of countries pre-COVID-19.

### THE HUMAN CAPITAL INDEX

**Human Capital Index.** A child born in the United Kingdom today will be **78 percent** as productive when she grows up as she could be if she enjoyed complete education and full health. This is higher than the average for Europe & Central Asia region and High income countries. Between 2010 and 2020, the HCI value for the United Kingdom increased from 0.77 to 0.78. Figure 1 shows how the HCI and each of the components evolved over time.

- **Probability of Survival to Age 5.** 100 out of 100 children born in the United Kingdom survive to age 5.
- **Expected Years of School.** In the United Kingdom, a child who starts school at age 4 can expect to complete **13.9 years** of school by her 18th birthday.
- **Harmonized Test Scores.** Students in the United Kingdom score **520** on a scale where 625 represents advanced attainment and 300 represents minimum attainment.
- **Learning-adjusted Years of School.** Factoring in what children actually learn, expected years of school is only **11.5 years**.
- **Adult Survival Rate.** Across the United Kingdom, **93 percent** of 15-year olds will survive until age 60. This statistic is a proxy for the range of health risks that a child born today would experience as an adult under current conditions.
- **Healthy Growth (Not Stunted Rate).** Data on stunting are not available for the United Kingdom.

### DIFFERENCES IN HCI ACROSS GENDER AND SOCIO-ECONOMIC GROUPS

In the United Kingdom, the HCI for girls is higher than for boys. Table 1 shows gender disaggregation for each of the HCI components.

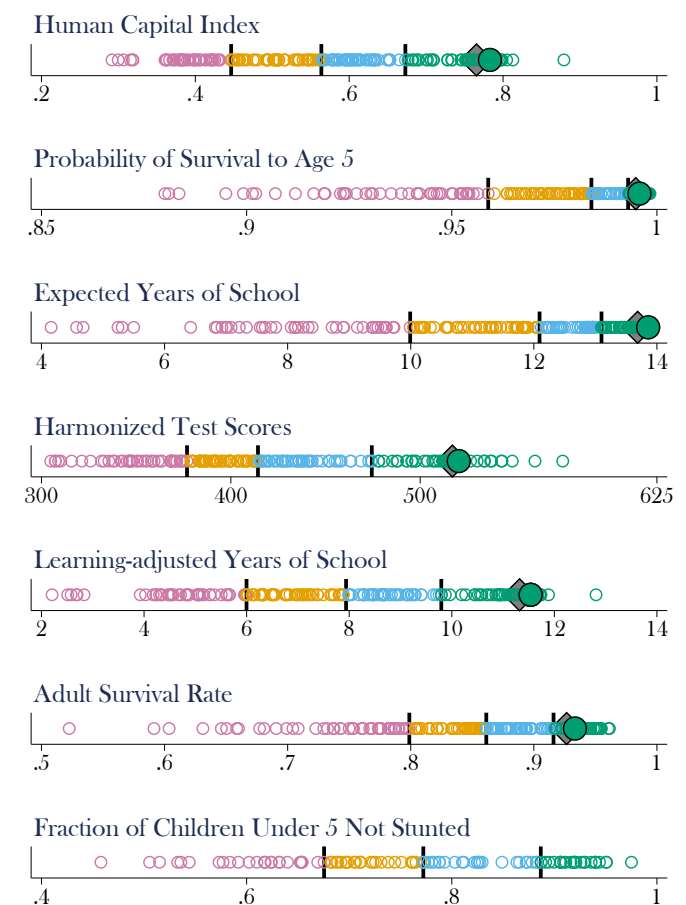
In the United Kingdom, there are not sufficient data to disaggregate HCI by socio-economic groups.

The outlook for the next generation has been improving in most countries in Europe & Central Asia. Efforts are being made to protect human capital gains against setbacks and accelerate progress for all. The challenges unleashed by COVID-19 require an even stronger policy response, including greater use of technology to improve service delivery and enhanced social assistance programs, to ensure that people receive quality education and health care.

### DOMESTIC RESOURCE UTILIZATION AND MOBILIZATION

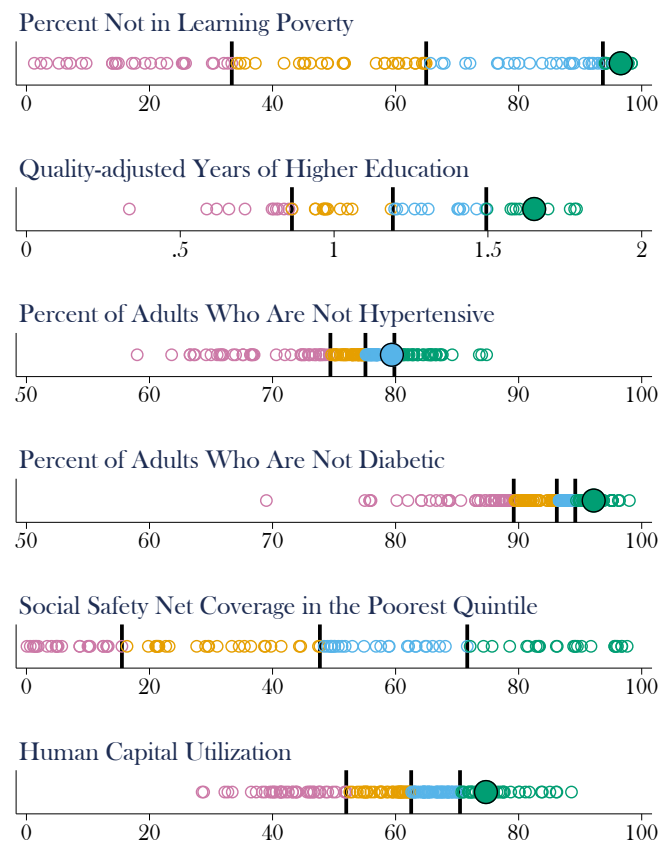
- **Health Spending.** The United Kingdom spends **7.6 percent** (2017) of its GDP in public spending on health. This is higher than both the regional average (4.9%) and the average for its income group (5.3%). **2 percent** (2013) of the population incurs catastrophic health expenditure measured as out-of-pocket spending exceeding 10% of household consumption or income.
- **Education Spending.** The United Kingdom spends **5.5 percent** (2016) of its GDP in government education spending. This is higher than both the regional average (4.6%) and the average for its income group (4.5%).
- **Social Assistance Spending.** In the United Kingdom, data on social assistance spending are not available. The average for its region is 1.8 percent and for its income group is 1.7 percent.
- **Government Revenue.** General government revenue in the United Kingdom is **36.9 percent** (2018) of GDP. This is lower than both the regional average (38.1%) and the average for its income group (37.3%).

### COMPLEMENTARY INDICATORS

- **Learning Poverty.** In the United Kingdom, **3 percent** (2016) of 10-year-olds cannot read and understand a simple text by the end of primary school. This is lower than both the average for its region (11%) and the average for its income group (14%).
- **Pre-primary Gross Enrollment.** In the United Kingdom, the gross enrollment ratio in pre-primary education is **106 percent** (2017). This is higher than both the average for its region (85%) and the average for its income group (91%).
- **Quality-adjusted Years of Higher Education.** In the United Kingdom, about **55 percent** (2017) of adults ages 30-34 have a tertiary degree. A child born today can expect to complete **1.9 years** of higher education. Factoring in the quality of higher education, expected years of higher education is only **1.7 years**.
- **NCD Deaths.** In the United Kingdom, the probability of dying between ages 30 and 70 from cardiovascular disease, cancer, diabetes, or chronic respiratory diseases is **11 percent** (2016). This is lower than both the average for its region (17%) and the average for its income group (14%).
- **Health Risk Factors.** In the United Kingdom **20 percent** of adults are obese, **17 percent** are smokers, and **22 percent** are heavy drinkers.
- **Hypertension.** In the United Kingdom, **20 percent** (2015) of the population age 18 and older has hypertension. This is lower than both the average for its region (29%) and the average for its income group (25%).
- **Diabetes.** In the United Kingdom, **4 percent** (2019) of the population ages 20-79 has type 1 or type 2 diabetes. This is lower than both the average for its region (6%) and the average for its income group (9%).
- **Universal Health Coverage (UHC) Index.** The index, ranging from 0 to 100, measures coverage of essential health services based on tracer interventions. In the United Kingdom, the UHC Index score is **87** (2017). This is higher than both the average for its region (75) and the average for its income group (79).

- **Social Safety Net Coverage.** In the United Kingdom, data on social safety net coverage of the poorest quintile are not available. The average for its region is 46 percent and for its income group is 70 percent.
- **Human Capital Utilization.** In the United Kingdom, **75 percent** (2018) of the working-age population is employed. This is higher than both the average for its region (65%) and the average for its income group (70%).
